Born May 5th 1943 in Hustisford Wis. To LeRoy and Beatta (Grukke) Fredrick. Grew up on a farm in Hustisford. Married David Greppi September 3rd 1961. They had a daughter Lola Lynn Greppi on March 28, 1967. They later divorced. After attending tech college in Beaver Dam Sandra went to work for Zweigs Grill in Watertown. A year later she started working at the Pinecone Restaurant in Johnson Creek. She met and married Marlys Baars on May 31, 1974. They started a custom butchering business and Sandra continued to work at the Pinecone also. Six years later they sold the business in the early 80s and moved to Fifield Wis. At this time they purchased some land and started the Baars mobile home court. At this time Sandra was working for the Flanagan Supper Club in Park Falls. Two years later they purchased the supper club. It was then called Family Inn. Located on the north end of Park Falls. They owned and operated it until it was lost in a fire in the early 90s. During this time Marlys and Sandra adopted Carol Lynn Poetzl. They increased the size of the mobile home court to 14 units all located in Fifield Wis. On January 2nd 2016 Sandra's husband passed and she suffered a string of heart attacks. So in December of 2016 the court was sold to Cornerstone Properties. Sandra still managed the court up until her death.

She is survived by two daughters: Lola Lynn Baars and Carol Lynn Voda. One Son: Kevin (LaBeth) Baars, Two grandchildren, Ryan Potscelli and Xaviar Voda. Also survived by step brothers and sisters, Wayne LeMacher (Ellie), Linda Blaser, (Steve) Mary Harshbarger (Dennis) and Frank LeMacher (Jeannie) and their children, grandchildren and great grandchildren, nieces and nephews.
